



## **SPONSORED MEMBERSHIP**

### **(Category 6)**

## **TERMS AND CONDITIONS**

### **Membership**

- An application for Category 6 (Corporate Membership) must be completed and signed by relevant parties
- Membership numbers for Category 6 are limited to 30 and entry is subject to approval of the Committee
- Category 6 membership is taken out in the name of the sponsor.
- The sponsor shall nominate an employee as the holder of the membership.
- The nominated member has the same rights and privileges as a Category 1 (Full) member of The Grange Golf Club and shall abide by the Constitution, rules and by-laws of the Club.

### **Fees**

- The fees payable for Category 6 membership as from 1<sup>st</sup> July 2011 are as follows:-

- \* The Entrance Fee is payable via the following methods:

- Paid in full within 30 days of invoice date – a discount of 10% will be applied
- Paid in 4 equal annual installments of \$3750.00 each – payable with subscription fees by 30th June each year.

- All other fees are payable annually and invoiced on 1<sup>st</sup> July each year. All fees are determined by the Club Committee and are reviewed on an annual basis.



### **Transfer**

- The membership is transferable with no transfer fee payable.
- The sponsor may cancel the membership of the nominated person and substitute another person to take up the membership.
- The transfer of membership is subject to approval by the Committee.
- It is important to remember there is only one membership at any one time.

### **House Levy**

- In addition to the annual subscription fees there is a pre paid House Account of \$2,250 per annum.
- Any money spent within the Clubhouse (food and beverage consumed on the premises) can be debited against this “House Account” including a corporate golf day or function at the Club.
- Green Fees and Motorised Cart Hire can also be debited against the “House Account”.
- Once the \$2,250 House Account has been used in full, future purchases will be invoiced with payment due within 7 days.
- The House Account must be used prior to the 30<sup>th</sup> June of each year, after which the balance remaining will be forfeited to the club.

### **Professional Shop**

- The Professional Shop located at The Grange Golf Club is a subcontracted business.
- All expenses incurred in the Professional Shop (i.e. clothing, equipment) will be billed separately and must be paid direct to Warren Mercer.
- Any amount owing cannot be offset against the “House Account”.

### **Golf**

- The nominated member may invite 3 visitors at any one time at the member introduced fee of \$50 per player.
- Any bookings of 4 or more will be charged at our corporate rate of \$75 per player and tee-off times must be arranged with the General Manager.
- The nominated member must be present at all times (unless prior arrangement with the General Manager).
